**New:** For co-exhibitors who exhibit with their own company or label/project at the booth of a registered exhibitor, we charge a fee of 100 € net per represented company/label/project. In return, they will be listed in the official exhibitor list and in the Fair Guide.

In case of non-registered co-exhibitors, we reserve the right to collect payment at the trade fair. In extreme cases, exclusion and expulsion from the hall may occur.

The remaining 50% of the stand rental fee must be transferred to our account by April 20, 2024.** Our General Terms and Conditions apply.

## BoundCon XIX Conditions of Participation

### § 1 Registration

1. The registration takes place exclusively by using the PDF or the online registration form of the organizer.  
The registration is binding. The organizer shall decide on admission (§ 3).

### § 2 Inclusion and acceptance

By registering, the applicant accepts the conditions of participation, any "special trade fair, festival and exhibition conditions" and technical guidelines of the organizer as binding for him and all persons employed by him at the trade fair. These regulations thus become part of the contract between the exhibitor and the organizer.

### § 3 Admission

1. Only those exhibitors can be admitted whose stand and exhibition contents correspond to the trade fair / convention concept of the organizer. The organizer may restrict individual stand areas for objectively justified reasons, in particular if the space available is insufficient. In case of obvious copied goods / designs, the organizer decides individually on the admission to the fair.
2. With the written confirmation of the admission, the contract between the applicant as exhibitor and the organizer is concluded. Admission will only be granted if the partial amount due after registration (50% of the invoice amount) has been paid within 30 days of receipt of the registration. Admission may be revoked if the conditions for its granting did not exist or subsequently ceased to exist.

### § 4 Reservation of subsequent changes

1. the organizer is entitled to postpone, shorten, extend or temporarily close or cancel the trade fair/convention in whole or in part in the event of unforeseen events that make it impossible to carry out the trade fair/convention as planned and for which the organizer is not responsible. Exhibitors' claims, irrespective of their legal basis, in particular for damages and reimbursement of expenses, are excluded. If the trade fair has to be closed as a result of force majeure or by order of the authorities, the exhibitor shall owe the full amount of the agreed stand rent and all other costs to be borne by him.
2. in the event of a postponement, exhibitors may demand cancellation of the contract if they can prove that the dates overlap with another trade fair for which they have already made firm bookings. They shall only be required to reimburse the costs incurred at their instigation.
3. in the event of a shortening or only temporary closure of the trade fair, the exhibitor shall not be entitled to any claims.

### § 5 Cancellation by the exhibitor

1. if a cancellation is made by 28.02.2024, the exhibitor will receive a full refund of the partial invoice amount paid up to that date. In the event of cancellations between 01.03.2024 and 01.05.2024, the organizer will demand 25% of the agreed stand rent incl. flat rates as a contribution to costs. In case of later cancellations, the full invoice amount will be due. Further costs incurred at the instigation of the exhibitor shall also be borne by the exhibitor.
2. cancellation requires a written application. It shall only become effective when accepted in writing by the organizer.

### § 6 Stand allocation

1. the arrangement of the stands shall be made by the organizer, taking particular account of the event concept and the theme specified by the trade fair/ convention.
2. until the hall plan has been drawn up, the organizer will try to take into account the exhibitor's wishes regarding stand form and placement. A claim does not exist. After that, the stands will be allocated according to availability.
3. the stand allocation will be communicated in writing at the latest 4 weeks before the fair.
4. the organizer is entitled at any time to relocate the entrances and exits to the exhibition grounds as well as the emergency exits and passages in the halls for compelling reasons.

### § 7 Subletting

1. the exhibitor is not entitled to sublet or otherwise let the stand allocated to him, in whole or in part, or to exchange it or accept orders for other companies without the approval of the organizer.
2. in the case of subletting to third parties not approved with the admission, the organizer is entitled to demand that the subtenant vacate the stand, whereby the exhibitor's obligation to pay rent remains unaffected.

### § 8 Joint stands

If several exhibitors rent a stand jointly, each of them shall be liable as joint and several debtor. They must name a joint representative in the application. This representative shall be deemed to be authorized to make and receive legal declarations of all kinds on behalf of the exhibitors.

### § 9 Rents, costs, terms of payment

1. the stand rents and surcharges result from the application or any "special trade fair, convention and exhibition conditions. The exhibitor shall bear the additional costs for additional orders or further ancillary services.
2. the invoice amount plus VAT is due in accordance with the payment terms stated on the invoice.
3. the exhibitor's right of set-off and retention is excluded, unless the claims are undisputed or legally established.
4. in case of unsuccessful payment reminder and corresponding written warning with final payment deadline, the organizer is entitled to terminate the contract with immediate effect.

### § 10 Right of termination of the organizer

- 1 The organizer is entitled to terminate the contract without notice if there is an important reason. Such cause shall be deemed to exist in particular if
  - a) The exhibitor is in default of payment and does not make payment within one week even after receiving a reminder.
  - b) The exhibitor disturbs other exhibitors or the operation of the trade fair or fails to comply with instructions or the house rules of the organizer.
  - c) The trade fair/exhibition does not take place in whole or in part - without prejudice to § 4.
2. the termination must be made in writing. The organizer can demand a minimum damage amounting to 50% of the agreed stand rent as compensation (lump-sum compensation). The assertion of a greater damage is not excluded. The exhibitor is free to prove that the organizer has suffered less damage than claimed.

### § 11 Design, equipment

1. the exhibitor must construct the stand in a sufficiently stable manner, including rear and side walls. Appropriate walls will be provided by the organizer and are included in the stand rental fee.
2. if the exhibitor dispenses with these walls and comes with his own complete stand, the stand rental fee is reduced to EUR 30.00 per m<sup>2</sup> (excl. flat-rate ancillary costs).
3. in the interest of a successful overall presentation, the guidelines and instructions of the organizer must be followed in the construction and furnishing of the stand.
4. the organizer may demand that stands whose construction is not approved or does not comply with the exhibition conditions be modified or removed. If the Exhibitor fails to comply with the written request within 24 hours, the Organizer may arrange for the removal or modification at the Exhibitor's expense. If the stand has to be closed, the exhibitor has no claims.

### § 12 Operation of the stand

1. during the opening hours of the event, the stand must be occupied with the registered goods, staffed with sufficient information personnel and kept accessible to visitors. Premature dismantling of the stand is not permitted and may be punished with a contractual penalty.
2. the operation of loudspeaker systems, musical/illuminated presentations, the demonstration of machines, devices and equipment of any kind as well as similar projects require the written approval of the organizer. Approval already granted may also be restricted or revoked in the interest of maintaining proper trade fair operations.
3. the exhibitor is responsible for the waste disposal himself! When disposing of waste, the legal regulations must be observed.

### § 13 Exhibitor passes

The following exhibitor passes are included in the stand rental fee:

For stand sizes up to 10 sqm: 2 exhibitor passes

For stand sizes up to 20 sqm: 3 exhibitor passes

For stand sizes over 20 sqm: 4 exhibitor passes

Additional passes can be ordered at a price of 21.00 Euro plus 19% VAT = 25.00 Euro per pass. However, a maximum of 8 additional passes per stand can be ordered. These passes are of course valid for all 3 days of the fair. The passes will be issued during the set-up in our fair office in the entrance area of the hall and must be collected there by all exhibitors themselves. Without a pass, there is no access to the hall on the exhibition days!

### § 14 Advertising

Advertising of any kind, in particular the distribution of printed advertising material, but also the addressing of visitors, is only permitted within the stand without the express permission of the organizer.

### § 15 Direct sale, hospitality

1. the direct sale of goods to third parties is permitted.
2. hospitality, in particular the sale of food, beverages, refreshments, luxury foodstuffs and foodstuffs of all kinds, is not permitted to the exhibitor.

## **§ 16 Prohibition of photography**

A general ban on filming applies at the trade fair.

Photography is prohibited outside the specially marked areas on the entire grounds of Boundcon.

Exceptions are specially marked and provided with a traffic light system.

Photographs may not be used commercially.

The use of flash and continuous light is prohibited.

Uninvolved persons and visitors who have not explicitly agreed to be photographed may neither be photographed nor be visible in the background.

Beyond the stage ALL photographed persons must actively agree to the photo shooting.

Boundcon employs its own photographers and videographers, who are identified as such with a T-shirt and/or badge. They are assigned to document the fair and the stage events. For this purpose they are allowed to take pictures everywhere without restrictions. Guests and/or visitors will also be shown recognizably by our staff only with their express consent.

## **§ 17 Fire protection**

Only materials of low flammability may be used for stand decoration. Open flames are prohibited on the stand.

## **§ 18 Cleaning**

The organizer shall be responsible for cleaning the aisles and exhibitor areas at night. The exhibitor is responsible for cleaning the stand area.

## **§ 19 Parking**

Parking spaces are available to exhibitors directly on the exhibition grounds at a charge.

## **§ 20 Security**

1. the organizer is responsible for the general security of the halls and the outdoor area, but without liability for loss or damage. Security begins with the first day of set-up and ends with the end of dismantling. 2.

2. the exhibitor is responsible for the supervision and guarding of the stand. This also applies during the construction and dismantling periods.

## **§ 21 Liability, Insurance**

The organizer assumes no liability for damage to exhibits, stand equipment or any consequential damage, unless the organizer is responsible for such damage due to intent or gross negligence. The organizer has taken out a liability insurance for his legal liability, which exclusively covers damages of third parties (visitors of the exhibition). Exhibitors, their personnel and their property are not included. Exhibitors are strongly advised to insure their exhibits at their own expense.

## **§ 22 Domiciliary rights**

(1) The organizer shall exercise domiciliary rights on the entire exhibition grounds during the construction, running and dismantling periods of the fair. He is entitled to issue instructions in general and in individual cases or to issue special house rules. 2.

Exhibitors and their personnel may enter the exhibition grounds one hour before the start of the fair and must leave one hour after the end of the fair at the latest. Overnight accommodation on the premises is prohibited.

## **§ 23 Forfeiture, Statute of Limitations**

1. claims of the exhibitor against the organizer arising from and in connection with the stand rental contract shall be deemed forfeited if they are not asserted in writing within one week after the close of the trade fair at the latest.

2. all other claims of the exhibitor and his employees against the organizer shall become time-barred within six months after the end of the trade fair/exhibition.

## **§ 24 Subsidiary agreements, amendments**

Deviations from these Conditions of Participation, the admission or, if applicable, further "Special Fair, Festival and Exhibition Conditions" or Technical Guidelines must be made in writing in order to be effective. Verbal subsidiary agreements shall not apply. This also applies to the waiver of the written form requirement.

## **§ 25 Place of performance and jurisdiction**

The place of performance and jurisdiction is Memmingen, Germany.
